

Legislation implementing the KPCS in the EC/EU
Last updated December 2008

The basic framework for implementing the KPCS in the European Community is established by [Council Regulation \(EC\) No 2368/2002](#) of 20 December 2002.

The Regulation has been amended on a number of occasions by means of Council and Commission Regulations, which cover matters such as the entry into force of certain provisions of Regulation 2368/2002, changes in the list of Participants in the KPCS, or the listing by the Commission of self-regulating industry organizations which is provided for in the Regulation.
