

Publication of an UPDATED **first list of external experts**

Following the open call for expressions of interest for the **list of external experts** launched by the Delegation of the European Union to Albania on 08/08/2014

This publication establishes a first list of external experts based on the of expressions of interests received by 30 September 2014 and meeting the selection criteria relating to technical and professional capacity as set out under point 11 of the open call for expressions of interest as published on 08/08/2014.

To be noted:

- the inclusion on the list entails no obligation on the part of the Delegation of the European Union to Albania (Contracting Authority) concerning the conclusion of contracts.
- before contracts are effectively awarded, the experts will be checked against the exclusion criteria as set out under point 10 of the open call for expressions of interest as published on 08/08/2014, notably point 10 (g) which stipulates that their participation will be excluded if:

'they have a conflict of interest in connection with the contract; a conflict of interest could arise in particular as a result of economic interests, political or national affinities, family or emotional ties or any other relevant connection or shared interest'.

As announced in the call for expressions of interest, for the purpose of transparency, a list of the experts who signed contracts with the EU Delegation to Albania will be published annually on the website of the EU Delegation. This list will indicate the specific task, the names of individuals, their localisation and their remuneration if it exceeds EUR 15.000 per signed contract.

The list resulting from this notice is valid for five years from dispatch of this notice. Interested parties may submit an application at any time prior to the last three months of validity of the list.
