The Delegation of the European Union to Botswana and SADC wishes to invite interested parties to express interest in providing technical assistance in the form of a Senior Advisor to strengthen the management and implementation capacity of Business Botswana in order to achieve the objectives of the Private Sector Development Programme (PSDP).

Contract description

Under the joint responsibility of the EU Delegation and Business Botswana (BB), services will be required for assisting the implementation of PSDP with various operational, administrative and financial advisory tasks.

The PSDP was developed within the framework of the Private Sector Development Strategy, in partnership with the Ministry of Investment, Trade and Industry (MITI) of the Government of Botswana, the Botswana Confederation of Commerce, Industry and Manpower (BOCCIM, currently Business Botswana) and with the Center for the Development of Enterprises (CDE) under the private sector component of the 10th EDF Empowerment of Non-State Actors program. The implementation of the initially three (3) years programme with the total budget of 2.8 Million Euro, started in April 2013 within the framework of a Contribution Agreement with CDE. Following the decision on the closure of the CDE, as well as the need to extend the duration of the programme, the implementation of the remaining activities were transferred to Business Botswana (BB) with a Grant agreement for duration of one year with a budget of 1,1 Million Euro. The program is meant to support private sector development for the purpose of improving the business environment in Botswana and stimulate economic diversification in the private sector as well as to increase the role of SMMEs in the economy. 1) Economic and financial capacity:

a. for natural persons:

• The financial situation of the candidate should not be in deficit, taken into account debts;

b. for legal persons:

o The average annual turnover of the candidate must exceed the maximum budget of the contract.

2) Professional capacity:

 The candidate is currently working/has worked during the past 5 years as manager and/or team-leader in fields related to private sector development.

3) Technical capacity:

 The candidate has worked successfully on at least one project, with a budget of at least that of this contract, in fields related to private sector development in the past five years

Interested parties are requested to submit written Expressions of Interest (EOI), including all relevant information to be able to asses compliance with all the selection criteria detailed above.
