- 4. Tenders must be:
 - signed by a duly authorised representative of the tenderer;
 - perfectly legible so that there can be no doubt as to words and figures;
 - drawn up using the model reply forms in the tender specification.
- 5. The period of validity of the tender, during which tenderers may not modify the terms of their tenders in any respect, is 6 months from the final date for submission.
- 6. Submission of a tender implies acceptance of all the terms and conditions set out I this invitation to tender, in the tender specification and in the draft contract and, where appropriate, waiver of the tenderer's own general or specific terms and conditions. Submission of a tender is binding on the tenderer to whom the contract is awarded for the duration of the contract.
- 7. All costs incurred during the preparation and submission of tenders is to be borne by the tenderers and will not be reimbursed.
- 8. Contacts between the contracting authority and tenderers are prohibited throughout the procedure save in exceptional circumstances and under the following conditions only:
 - Before the final date for submission of tenders:
 - At the request of the tenderer, the contracting authority may provide additional information solely for the purpose of clarifying the nature of the contract.
 - Any requests for additional information must be made in writing only to DELEGATION-CHINA-TENDERS@eeas.europa.eu.
 - Requests for additional information received less than five working days before the final date for submission of tenders will not be processed.
 - The contracting authority may, on its own initiative, inform interested parties of any error, inaccuracy, omission or any other clerical error in the text of the call for tenders.
 - Any additional information including that referred to above will be sent simultaneously to all candidates invited to tender.

- If clarification is required or if obvious clerical errors in the tender need to be corrected, the contracting authority may contact the tenderer provided the terms of the tender are not modified as a result.
- The contracting authority may negotiate with tenderers the tenders they have submitted, in order to adapt them to the requirements set out in the contract notice, tender specifications or any additional document and in order to find the tender offering best value for money. During negotiations equal treatment of all tenderers will be ensured.
- 9. This invitation to tender is in no way binding on the contracting authority. The contracting authority's contractual obligation commences only upon signature of the contract with the successful tenderer.
- 10. Up to the point of signature, the contracting authority may either abandon the procurement or cancel the award procedure, without the candidates or tenderers being entitled to claim any compensation. This decision must be substantiated and the candidates or tenderers notified.
- 11. Once the contracting authority has opened the tender, the document shall become its property and it shall be treated confidentially.
- 12. You will be informed of the outcome of this procurement procedure by e-mail. It is your responsibility to provide a valid e-mail address together with your contact details in your tender and to check it regularly.
- 13. If processing your reply to the invitation to tender involves the recording and processing of personal data (such as your name, address and CV), such data will be processed pursuant to Regulation (EC) No 45/2001 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data. Unless indicated otherwise, your replies to the questions and any personal data requested are required to evaluate your tender in accordance with the specifications of the invitation to tender and will be processed solely for that purpose by the Chargé d'affaires a.i. of the EU Delegation to China. ANNEX I - TENDER SPECIFICATIONS

1. INTRODUCTION

The European External Action Service, here represented by Ms Carmen Cano, Chargé d'affaires a.i. to China and Mongolia (the Delegation), intends to sign a purchase order for painting some offices at South Wing of the Delegation and a gate at the Residence according to the specifications hereafter.

2. SUBJECT OF THE CONTRACT

The successful tenderer shall paint some offices at South Wing of the Delegation (incl. one staircase in the HoD zone) and a gate at the Residence.

The maximum indicative price of the contract shall be 41,000 CNY.

3. TECHNICAL SPECIFICATIONS

- 1) The successful tenderer shall make sure that workers are capable of providing high-quality service and will follow the Delegation's security rules.
- 2) For the offices at the South Wing (incl. one staircase in the HoD zone),
- Odourless, environmental-friendly paint shall be used (either Dulux or Nippon odourless paint);
- In case of cracks, the wall shall be repaired before it is painted.
- 3) For the gate at the Residence,
- Painting is peeling off in some corners of the gate, and it shall be repaired before any painting is done. Proper prep work shall be done to ensure the paint is not easily peeling off;
- The colour of the paint shall be the same as the current one.
- 4) A site visit on 21/08/2015 to the Delegation's premises (15 Dongzhimenwai Dajie) is compulsory in order to participate in the tender.
- 5) The contract shall be implemented within 6 months as of the signature of the contract, with the notification to the tenderer a week earlier before the printing work is planned.



4. CONTENT AND PRESENTATION OF THE TENDER

Prices must be:

- o Denominated in CNY;
- o Unconditional and all inclusive;
- Drawn up using the price sheet attached (Annex II price sheet, duly completed and signed).

Submission of a tender implies that the tenderer:

- o Accepts all the terms and conditions governing the purchase order;
- o Waives its own terms and conditions;
- o Period of validity of the tender: 6 months from the deadline for the submission of tenders.

5. EVALUATION OF TENDERS

Automatic award: the contract is awarded to the lowest tender that satisfies the technical specifications.
