### **Naryshkin: Russia to suspend involvement in PACE in case of another attempt to limit its powers**

The Russian delegation to the Parliamentary Assembly of the Council of Europe (PACE) is likely to suspend its involvement in PACE activity in the near future if its powers are limited again at the January session, State Duma Speaker Sergei Naryshkin said.
