In his report the CoE Commissioner addresses a number of issues concerning the administration of justice and the protection of human rights in the justice system of Armenia, in particular, in regards to the deadly 2008 post-election clashes, the conviction of an oppositionist's teenage son, non-combat deaths in the Armenia and others.

<u>Human Rights Court: Hungary's prisons inhumanely overcrowded</u> 10/03/2015 - Hungary Today

In their chamber judgment in the case of Varga and Others v. Hungary the ECHR judges held, unanimously, that there had been a violation of Article 3 (prohibition of inhuman and degrading treatment) of the European Convention on Human Rights, and a violation of Article 13 (right to an effective remedy) read in conjunction with Article 3 of the convention.
