Russian, Belgian diplomats to discuss implementation of Minsk Agreements 08/04/2015 - Sputnik News

Russian Foreign Minister Sergei Lavrov and his Belgian counterpart Didier Reynders will discuss the possible role of the Council of Europe in the Minsk agreements implementation, including implementation of the constitutional reform in Ukraine.

<u>Savchenko's lawyers to appeal against refusal to recognize her PACE delegate immunity</u> 07/04/2015 - Ukrinform

The lawyers of Ukrainian pilot, MP and delegate of the Parliamentary Assembly of the Council of Europe Nadiya Savchenko have lodged a new complaint in the Basmanny district court of Moscow against refusal of the Investigative Committee to recognize the immunity of Savchenko as the PACE delegate.

<u>Crimean man accused of terrorism appeals to European Court over 'forced' Russian</u> citizenship

A Moscow court ruled that a Crimean man arrested on suspicion of terrorism will remain in detention in Moscow through May 16, days after he filed a complaint with the European Court of Human Rights claiming that he was illegally forced to give up Ukrainian citizenship and become Russian, the BBC's Russian-language service reported Thursday.

# Italy found guilty of using torture during G8 protest

In a landmark judgment, the European Court of Human Rights yesterday found Italy guilty of using "torture" against protesters at the G8 Summit in Genoa 2001. The court also expressed its regret that, due to both Italy's extensive Statute of Limitations legislation and to a "lack of co-operation from police authorities", no police personnel had been sanctioned or prosecuted for their role in the "totally gratuitous" violence perpetrated on the "No Global" protest movement.

# <u>Immigrants in Spain held in 'carceral' environment - Anti-Torture Committee</u>

Meetings are also scheduled with parliamentary groups of the National Assembly, the Armenian delegation to PACE and representatives of civil society. Ms Brasseur will also meet students of Yerevan State University.

### PACE President Brasseur highlights press freedom issues in Turkey
