Secretary General / Polish Constitutional Crisis

Council of Europe says Poland risks lawsuit over court reform

The paralysis in Poland's constitutional court puts Warsaw at risk of a lawsuit in the European Court of Human Rights, the head of the rights body the Council of Europe said on Monday.

Poland's eurosceptic Law and Justice (PiS) party has faced growing pressure from the EU, the United States and other bodies since it swept to power in the bloc's largest eastern member state in October and increased controls on media and other institutions.

The conservatives have enacted a law increasing the number of judges required to make rulings on the Constitutional Tribunal and changing the order in which cases are heard.

Critics say the changes have made it difficult for judges to review new legislation, let along challenge it, and the court itself has struck them down as unconstitutional. The government has refused to recognize that ruling, effectively putting it in legal limbo.

Council of Europe chief urges Poland to resolve constitutional crisis

If its constitutional crisis continues much longer, Poland risks lawsuits in the European Court of Human Rights. With this in mind, the Council of Europe Secretary General has urged Polish lawmakers to end the crisis.

Thorbjoern Jagland said he was concerned that the European Court of Human Rights may soon have to start receiving complaints from individuals in Poland that the country's constitutional tribunal would normally hear, but - because it is unable to sit for political reasons - would have to go to the Strasburg-based court instead.

"And it is unprepared to handle them," he said.

"The concern is that if the constitutional crisis continues a new complaint or application to the European Court of Human Rights in Strasbourg may arrive, given that the Polish judiciary has been weakened by the constitutional crisis," Jagland told reporters on a two-day visit to Warsaw starting Monday.

"This could be problematic because the court, based in Strasbourg, is already overburdened," he added.

Jagland called on Poland's parliament to resolve the crisis, which he said has paralyzed the constitutional court and hurt the rule of law.

Thorbjørn Jagland OP-ED: Protect the thousands of burial sites across Central and Eastern Europe

In the Jewish faith, burial sites are even more sacred than synagogues. Not just cemeteries, but also the mass graves created during the Second World War. These are the "houses of the living" where souls remain unbreakably linked to their former bodies, awaiting the resurrection.

Yet, across Europe, countless such sites have fallen into disarray. The causes are mixed: desecration and grave robbing, yes, but also poor management, short-sighted town planning and a lack of funds. Many have become overgrown. Some have been sold off, only to end up as hotel complexes and leisure parks. Few have benefited from clear local guardians. The loss of Jewish cemeteries on European soil is a problem. And not just for historians or the descendants of the deceased, but for all those who value tolerant and inclusive societies.

The Council of Europe – the continent's human rights watchdog – will therefore lend its support to an ambitious project, run by the ESJF European Jewish Cemeteries Initiative and funded, in part, by the German government, to protect the thousands of burial sites across Central and Eastern Europe.

Tomorrow [9 April], I will join Yossi Beilin, a former Israeli minister and long-time peace advocate, in the Polish town of Frampol. Here the sizeable Jewish population perished under German occupation.

Children want social justice and an end to violence – we must listen to them

What do children want? Businesses spend billions of euros every year on publicity campaigns trying to convince us that children want the latest toys, games, junk food and branded clothing. But when we ask children directly, a completely different picture emerges.

The Council of Europe is about to publish an overview of children's opinions and priorities – based on more than 100 studies from across Europe – which reveals that children focus, first and foremost, on fundamental needs, not passing fads and desires. They want social justice and an end to violence, bullying and discrimination. Education is a priority, as well as families having enough money for food, housing and health care. Children want to be consulted, taken seriously and to influence their own care, budgetary decisions and the provision of facilities.

Officials took part in Council of Europe conference in Bulgaria capital (ROUNDUP)

President of the Republic of Bulgaria Rosen Plevneliev opened a high-level conference of the Council of Europe, which will present the new Council of Europe Strategy for the Rights of the Child (2016-2021), the press centre of the President's Office announced.

The forum set the start of the implementation of the strategy, which was adopted on March 2, 2016 during the Bulgarian Chairmanship of the Council of Europe Committee of Ministers. This is the third strategy for the rights of the children under the "Let's build a Europe with and for children" programme.

The two-day forum is hosted by the Bulgarian State Agency for Child Protection and the Ministry of Labour and Social Policy.

The forum will continue until April 6. There will be nine themed sessions, as the participants will have the chance to learn and discuss the latest developments in the severest challenges covered by the Strategy.

The intended priority areas covered during this new strategy period are as follows: equal opportunities for all children; participation of all children; a life free from violence for all children; child-friendly justice for all children; rights of the child in the digital environment.

The list of high-ranking officials, who will attend the forum, also includes: President of Malta Marie Louise Coleiro Preca, Deputy Secretary General of the Council of Europe Gabriella Battaini-Dragoni; Bulgarian Deputy Prime Minister for Demographic and Social Policies and Minister of Labour and Social Policy Ivaylo Kalfin; Minister of Foreign Affairs Daniel Mitov; other ministers and experts in social policies and children's rights.

Delegation of CoE to visit to monitor local authorities issues

A delegation of the Congress of Local and Regional Authorities of the Council of Europe (CoE), will conduct a monitoring visit to Cyprus from Tuesday to Thursday.

The rapporteurs Bernd Vöhringer and Randi Mondorf will assess the implementation of the European Charter of Local Self-Government in the country.

Cyprus signed the Charter I August 1986 and ratified it in May 1988. The Charter commits member states to guarantee the political, administrative and financial autonomy of local authorities.
