- 3. Follow-up with O R and Reach Centrum (CEFIC) for formation of consortia/its exact position before pre-registration i.e. 1st December 2008 & after pre-registration when ECHA will announce SIEF i.e. 1.1.2009.

4. Follow-up with OR / CEFIC (SIEF FORMATION) and Jai Research Foundation for identifying the data gaps and give the following conclusions:

- Advise the members on steps to be carried out based on SIEF Reports
- Cost thereof and cost of final Registration
- Assist Jai Research in upgradation if any in carrying out tests
- Finally help manufacturers to formulate his export strategy based on the profitability vis-à-vis cost of registration and advise him on the registration.
- Re-imbursement of 50% of the registration charges under MAI with the value cap of Rs.5 lacs per product and 5 products per year.

1.OR or Third Party Representative

- Sustainability Support Services (Europe) AB (SSS) which is the EU based legal entity (based in Sweden), has been appointed for the purpose of 'Only Representative services and / or Third Party Representative', where identity is camouflaged and C B I (Commercial Business Information) is flagged out. They will be responsible for coordinating with REACH Centrum (CEFIC) along with Tec. Expert from India for advising on data gaps and SIEF formation.
- After formation of SIEF, OR/Tec. Expert he will inform to Jai Research Foundation for carrying out requisite tests.
- Jai Research Foundation will follow all norms and procedures as prescribed with REACH for respective data generation and analytical activity.


