# TRAINING SEMINARS ON HUMAN RIGHTS FOR REPRESENTATIVES OF LOCAL PUBLIC AUTHORITIES

On 24 and 25 November, the EU-funded and Council of Europe-implemented "Democracy Support in Moldova" in co-operation with the Centre for Human Rights of Moldova organised two training seminars on human rights for representatives of local public authorities, held in Balti and Edinet.

Following the publication of the Manual on human rights for civil servants, a series of training seminars on human rights for LPA representatives in 5 cities from different regions of the country has been organised.

Other training seminars shall be organised in Cahul, Comrat and Chisinau. The bulk of the Manual's copies shall be disseminated among civil servants and other beneficiaries during further trainings and other activities of the Moldovan Ombudsman Institution. ## KNOWLEDGE TRANSFER WORKSHOP FOR GOVERNMENTAL AND ACADEMIA REPRESENTATIVES

On 23-25 November, the EU-funded "Building training and analytical capacities on migration in Moldova and Georgia" (GOVAC) project organised in Chisinau a knowledge transfer workshop for governmental and academia representatives.

The aim of the workshop was to present and analyse the possible professional and academia migration training models existing in the European Union and Schengen countries, to undertake the first activities on the mapping of the migration curricula and their content, and to discuss possibilities of future cooperation between Government and Academia.

The main results of the workshop were first drafts of governmental and academia migration curricula which were developed jointly by Moldovan and foreign experts during the working groups sessions. The curriculum will be finalised and agreed by all project partners in the nearest future.

# SOLUTIONS TO OVERCOME THE POLITICAL CRISIS PROPOSED THE PRESS CLUB

On 24 November, the Independent Journalism Centre held in Balti a press club to discuss the political crisis and the need to elect the president. The event was organised within the EU-funded project "Strengthening the capacity of media to reflect topics of public interest". Journalists and experts discussed at the press club the political consequences of the crisis on citizens and proposed solutions to overcome it. Thus, the journalists believe that a major constitutional reform must be implemented, but political analysts suggest that the full involvement and pressure from European partners would contribute to overcoming the political crisis in Moldova.

The participants discussed the voter attitudes towards a new round of elections. According to Ruslan Mihalevschi, deputy editor of the "SP" newspaper in Balti, ordinary people are already tired of this crisis, they need political and economic stability. ## **EU-FUNDED PROJECT SUPPORTS CCA IN DESIGNING GUIDELINES ON MINORS PROTECTION FOR BROADCASTERS**

On 24 November, the EU-funded and Council of Europe-implemented "Democracy Support in Moldova" in co-operation with the Coordinating Council of Audiovisual (CCA) organised a workshop on designing guidelines on minors protection for broadcasters.

The main purpose of this activity was to learn about the ways used in EU Member States to address the matters of protection of minors in broadcasting and to discuss proposals for the guidelines on minors protection for Moldovan broadcasters. The practice of the European regulatory authorities in protecting children from harmful audiovisual content and behaviour was presented by Richard Carver, Executive Director of Oxford Media Research.

During the forthcoming weeks Richard Carver will be providing advice and assistance to CCA in designing the guidelines on minors protection for Moldovan broadcasters. CCA plans to adopt the new guidelines by late December.

## DISCUSSIONS ON THE FIRST DRAFT OF THE NEW ADMINISTRATIVE CODE

On 21 November, the first draft of the new Administrative Code designed under the EUfunded and Council of Europe-implemented "Democracy Support in Moldova" was discussed by technical experts and judges.

A total of 25 national experts and judges discussed the concept of the new Administrative Code and reviewed its main chapters. The document was designed in a co-ordinated effort of the Ministry of Justice, the Standing Committee on Legal Affairs, Appointments and Immunities and the Legal Department, both under the Parliament of Moldova, as part of the 2011-2015 Strategy for the Justice Sector Reform. Once all comments and suggestions are approached, the draft Administrative Code shall be submitted to the Parliament of Moldova for further review and adoption.

# INTERNATIONAL SYMPOSIUM TACKLING FORESTRY SUSTAINABLE DEVELOPMENT

On 17-19 November, the EU-funded programme "Improving Forest Law Enforcement and Governance in the European Neighbourhood Policy East Countries and Russia" (ENPI FLEG) joined the Agency "Moldsilva" and the Institute of Forest Research and Management (ICAS) in celebrating the International Year of Forests 2011 by organising the International Symposium "Sustainable Development of Forestry Sector – New Objectives and Priorities". More than 200 participants from Azerbaijan, Armenia, Moldova, Romania, Russia and Ukraine, as well as international organisations discussed the new objectives and priorities in maintenance, conservation and sustainable development of forestry sector by using new application of forestry monitoring, silvocultural works, improvement of economical-financial mechanisms in community forest management.

# EUBAM JOINT OPERATION REPORTS BORDER SEIZURES WORTH EUR 3.2 MILLION

On 16 November 2011, the EU Border Assistance Mission to Moldova and Ukraine (EUBAM) published the results of the Joint Border Control Operation (JBCO) AKKERMAN showing a substantial increase in the number of detections and seizures made during the 2011. AKKERMAN is the 8th JBCO to have been coordinated by EUBAM together with its border-guard, customs, and law-enforcement partners in Moldova and Ukraine, and international organisations and law-enforcement authorities of EU Member States. As with previous JBCOs, its areas of operations were the Moldova-Ukraine border, plus Odessa and Ilyichevsk ports.

During two intelligence-led operational phases conducted in 2011 – the second of which took place in September – AKKERMAN managed to seize smuggled goods such as cigarettes, alcohol and stolen vehicles, and detect customs fraud, worth EUR 3.2 million.
