#### **EU-FUNDED PROJECT TRAINS CONSULAR OFFICERS TO DELIVER BETTER SERVICES**

On 12–14 July the EU-funded and IOM-implemented project "Supporting the implementation of the migration and development component of the EU-Moldova Mobility Partnership" held a training session, entitled "Improving the skills of the consular officers from the diplomatic missions and consular offices of the Republic of Moldova abroad to grant consular assistance". The training was organised in cooperation with the Ministry of Foreign Affairs and European Integration, addressed to consular interventions on issues related to relationships with migrants and Diaspora initiatives.

The Consular Officers were trained on: legal protection of Moldovan citizens abroad and the implementation of readmission agreements, citizen documentation, transcription of civil status acts, procedural changes in the role of the Civil Registry Of-



fice, information channels and assistance services regarding migrants' return and reintegration. Special accents were made on Diaspora management and the role of Consular Officers in preventing and combating human trafficking.

# **EU-FUNDED PROJECT HOLDS MONITORING MISSION TO THE MIGRANTS ACCOMMODATION CENTRE**

On 16 July the EU-funded project "Technical Cooperation and Capacity Building for the Governments of Ukraine and Moldova for the Implementation of Readmission Agreements with the European Union (GUMIRA)" held the second Observatory Mechanism Mission to the Centre for Temporary Accommodation of Irregular Migrants (MAC) of the Moldovan Ministry of Internal Affairs. The Mission was composed of more than 20 representatives from Government agencies, NGOs, diplomatic missions and international organisations accredited in Moldova.

During the Mission, the participants were able to assess the existing accommodation conditions for migrants within the MAC, as well as the legal and social assistance systems for migrants established within the Centre; including recent developments



following the previous Mission in November 2009. The participants were able to present their views on the subject, and while generally satisfied with the level of assistance and protection for migrant's rights within the MAC, still provided recommendations on how to improve the situation and to enhance the cooperation in respective areas.

#### **EU-FUNDED PROJECT SUPERVISES THE FIRST TV DEBATES ON CONSTITUTIONAL REFERENDUM**

On 6–7 August the EU-funded and Council of Europe-implemented "Democracy Support Programme in Moldova" organised a workshop on referendum debates for the journalists, editors and producers of the public broadcasting company Teleradio-Moldova. Some 17 participants were trained by the former programme director of the Dutch national broadcasting company, and an editor of Radio Romania. The purpose of the session was to look at how to design, produce and broadcast the TV and radio debates on constitutional referendum.

On 9–12 August the international experts offered coaching and support to other specific groups from Teleradio Moldova on planning and broadcasting the debates on constitutional referendum. They have worked during four days in the studious of "Teleradio Moldova", helping the teams from public TV and



radio channels to design and broadcast the first debates on constitution referendum. The experts supervised directly the broadcast of first two TV debates at "Moldova 1" TV channel on 12 August.

The initial feedback from outsiders was positive: some local and international experts have noticed "encouraging qualitative changes" in designing and broadcasting of political debates on "Moldova 1". The new format and decor, more participants, better camera moves and lighting improved the quality of debates on public broadcaster.

#### EU SUPPORT TO REFORM AND MODERNISATION OF MOLDOVAN POLICE SERVICE

On 9–13 August the EU-funded project "Support to the Implementation of EU-Moldova Agreements" held in Vadul-lui-Voda in co-operation with the EU Delegation to Moldova and the EU High Level Policy Advice Mission to Moldova a working session on the future reform and modernisation process of Moldovan police service, in line with the best international and European practice.

The event was organised at the initiative of the Ministry of Internal Affairs (MAI) and aimed at elaboration of a Police Reform Road Map – a strategic document that will foster the placement of MAI within an inter-institutional context and will serve as a basis for future assistance initiatives from external donor organisations.



The Head of Political and Economic Section of the EU Delegation Wolfgang Behrendt and the Minister of Internal Affairs Victor Catan opened the first working session for experts from MAI, Supreme Court of Justice, Prosecutor General's Office, Border Guard Service, Centre for Combating Economic Crimes and Corruption, State Chancellery, Parliament and field NGOs. Prime Minister Vladimir Filat closed the event on 13 August with a session and conclusions and recommendations.

#### **EU-FUNDED PROJECT HOLDS TRAINING THE BEST 20 EDITORS AND SENIOR JOURNALISTS**

On 13–15 August the EU-funded and Council of Europe-implemented "Democracy Support Programme in Moldova" organised in partnership with the Central Election Commission a workshop on media coverage of the constitutional referendum. The training was attended by the best 20 editors and senior journalists from media outlets in Moldova, inclusively editors from Transnistria and Gagauzia.

The training featured lecturers and presentations by the former programme director of Dutch national broadcasting company, the editor-in-chief of Dutch national public TV, and an editor from Radio Romania. The participants also had a chance to get first-hand information from the Secretary of Central Election Commission, on the proper use of the electoral terminology and reporting techniques on electoral procedures.



The event included practical sessions on legal provisions and boundaries for media coverage during elections and responsibilities of media personnel in coverage of the referendum and related constitutional amendments.

# EU-FUNDED PROJECT ON SUPPORT TO THE HEALTH REFORM HOLDS FINAL CONFERENCE

On 24 August the EU-funded project "Support to the Health Reform: Strengthening of Primary Health Care (PHC) in Moldova" held the Final Conference aimed to demonstrate the major achievements of the project's activities, as well as the challenges and needs for the future in order to further develop PHC in Moldova as a basis for health care service delivery. The project with a budget of €1.2 million was implemented during September 2008-August 2010 and contribute to an effective coverage of Moldova with quality primary health care services.

After two years of operation the project invited the beneficiary, the Ministry of Health, and the funding agency, the EU Delegation to Moldova, as well as involved stakeholders from the rayons and Chisinau, in order to conclude the project. The Political Officer of the EU Delegation Dirk Lorenz and Minister of Health Vladimir Hotineanu underlined both the importance and success of the project for the further development of PHC in Moldova.

The project improved the efficiency and quality of the services at PHC level and strengthened the capacity of health management and medical personnel in PHC, through development of a mechanism for elaboration of Clinical Guidelines and Protocols for PHC; development and carrying out of a public information and awareness campaign; strengthening of the capacities, knowledge and skills of practitioners in PHC; defining the concept of a decentralised information system in the PHC.

# **EU-FUNDED PROGRAMME TO PROVIDE LOGISTIC SUPPORT TO THE REFERENDUM ON 5 SEPTEMBER**

On 25 August the EU-funded and Council of Europe-implemented "Democracy Support Programme in Moldova" announced about a contribution to the Government of Moldova in the amount of approximately 1.1 million lei to assist the conduct of the constitutional referendum on 5 September 2010.

This contribution responds to the requests of the Government in addressing the challenges associated with the organising of the referendum, including the voting in the out-of-country polling stations.

The funding will enable critical assistance to the newly established polling stations abroad, and support key activities such as deployment of the staff of the Ministry of Foreign Affairs and European Integration and acquisition of equipment and material necessary for the conduct of referendum abroad.

Furthermore the conduct of the referendum will be observed through a separate initiative supported by the Joint Programme.
