6. Description of the market

The contract concerns the implementation of the rehabilitation of the national road No. 11, section Zinder - Border Nigeria divided into two lots:

Lot # 1 : Section Zinder - Bande 75.3 km

Lot No. 1-2 : Section Zinder - Bande (firm phase) 72.1 km

Lot No. 1-1 : Crossing Zinder (conditional tranche) 3.2 km

Lot # 2 : Section Bandaged - Magaria - Fr Nigeria 40.7 km

Major works to be performed are :

CONDITIONS OF PARTICIPATION

8 . Eligibility and rules of origin

Participation in tendering is open on equal terms to natural and legal persons (participating either individually or in a grouping (consortium) of tenderers) which are established in one of the ACP countries , a member of the European Union or in a country or authorized by the ACP -EC Partnership Agreement under which States territory the contract is financed (see also item 22 below) participation in the procedure is also open to international organizations. All goods supplied under this contract must originate in these countries.

9 . Grounds for exclusion

Tenderers must submit a signed declaration , included in the tender form for a supply contract , that they are not in any of the situations listed in point 2.3.3 of the Practical Guide to contract procedures for EC external actions of the EU.

10 . Number of offers

Tenderers may submit only one tender per lot. Tenders for only part of a lot will not be considered. Any tenderer may state in its tender that it would grant a discount should their tender be awarded several lots. Tenderers may not submit a tender for a variant solution in addition to their tender for the works required in the tender dossier .

11 . Tender guarantee

Tenderers must provide a tender guarantee of :

Lot 1: 110 million FCFA or equivalent in EUR

Lot 2: 70 million FCFA or equivalent in EUR

This will be returned to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer after the contract is signed by all parties . This guarantee will be called upon if the tenderer does not honor all the obligations stipulated in the invitation to tender.

12 . Performance guarantee

Will be asked to provide Contractor performance guarantee equal to 10 % of the value of the contract at the signing of the contract. This guarantee must be provided with the countersigned contract no later than 30 days after the receipt by the tenderer of the contract signed by the contracting authority . If the tenderer does not furnish the bond within the time allowed, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

13 . Information meeting and / or site visit

An information meeting and a mandatory site visit will be organized by the Directorate General of Major Projects , Project Manager .

SELECTION AND AWARD

16 . Selection Criteria

Criteria of economic , technical and professional capacity according to the criteria in section 12.2 of the Instructions to Bidders

Economic and financial capacity of candidate :

The average annual turnover (single bidders or group) within three (3) years must be equivalent to 4 million or equivalent in CFA francs for lot 1 and 3 million or equivalent CFA francs for lot 2 .

The single tenderer or the group should have access to credit and other financial facilities to cover sufficient cash flow , " cash flow " required for the duration of the contract . In all cases , the amount of credit available for this specific project must exceed 2.5 million or equivalent in CFA for lot 1 and EUR 1.5 million for Lot 2 .

Technical and professional capacity of candidate:

Specific experience in the field of road infrastructure in developing countries and / or transition in the last 5 years from the deadline for submission (projects considered should only refer to the construction and / or rehabilitation and / or periodic maintenance of paved roads): one (1) completed a similar importance and the amount of project : 4,000,000 euros or equivalent in CFA for Lot 1 and \$ 3 million euros or equivalent in CFA for lot 2 .

Specific experience of members of a group : the entire group must satisfy at least the values mentioned above.

This means that the project which the tenderer refers may have begun or have been executed or have been completed at any time during the period shown, but do not necessarily have begun and been completed during this period, or have been performed during the entire period.

The tenderer must carry out at least 70% of the contract works by his own means, which means he must have the equipment, materials , human and financial resources to enable it to perform this market share .

- If the main partner of a consortium, it must perform at least 50% of the contract works by its own means .

- If another member of a consortium (ie not the lead partner) it must have the ability to perform at least 10% of the contract works by its own means .

Note: Copies of certificates of final acceptance (or at least provisional acceptance without reservation) signed by the duly authorized representatives should be included in the submission and attached to projects that are cited as specific experience .

Minimum quality of key personnel responsible for execution of work:

- Chief Construction Engineer must be a Civil Engineering Degree + 4 or equivalent , and ten (10) years of experience in the road sector three (3) years of which as a site manager for similar work , with a successful experience of ten (10) months in sub-Saharan Africa.
- Quality Engineer: five (5) years experience in major road works two (2) years of which as quality engineer with a successful experience on one (1) road project in sub-Saharan Africa.
- drivers work : five (5) experience in major road projects including two (2) as clerk of works for extensive work of a similar nature and with successful experience of six (6) months in Africa Saharan Africa.
- Chief Engineer : five (5) years of experience in major road works, with successful experience of six (6) months in sub-Saharan Africa.
