## EU SUPPORT TO UKRAINE ON THE EU-UKRAINE READMISSION AGREEMENT

The EU strongly supports its Ukrainian partners in addressing common challenge of irregular migration. The EU has been providing support through a number of different projects and programmes including the "Capacity Building and Technical Support to Ukrainian authorities to Effectively Respond to Irregular Transit-Migration (ERIT)" project (see below).

This project started in February 2009, and came at the pertinent time, nearly a year before the entry into force of Readmission Agreement (1 January 2010). When concluding the readmission agreement, the European Union agreed to help Ukraine in establishing necessary infrastructure and procedural standards for the proper implementation of the agreement.



The EU continues to place border management and migration at the heart of its co-operation with Ukraine. The EU has allocated EUR 35 million under its ENPI 2007 National Programme for Ukraine for improving infrastructure and procedures related to the accommodation and treatment of irregular migrants ("Readmission-related assistance").

The EU is also currently funding the IOM-implemented "Technical cooperation and capacity building of Ukrainian and Moldovan governments for implementation of readmission agreements with the European Union (GUMIRA)" project. This project includes training on legal, technical and administrative aspects of readmission, the development of a methodology for monitoring and evaluation of governmental bodies' activities in the field of readmission, and awareness-raising of civil servants on readmission-related matters.

#### **EU INVESTS IMPROVEMENT OF UKRAINIAN DETENTION CENTRES**

The European Union has recently invested EUR 140 000 for further improvement of two existing detention centres in Rozsudiv (Chernihiv oblast) and Zhuravichi (Volyn oblast).

In both centres modern perimeter security systems were installed. In addition, Rozsudiv DC received power stabilizators to eliminate problems with electricity supply and to ensure optimal functioning of the provided security equipment. Zhuravichi DC received tourniquet system with registration cards for migrants, electronic door locking system, security window tapes and bars for dormitories. The perimeter protection system will prevent migrants from escapes while the internal system will ensure security of staff working in the centres and facilitates



management of possible mass conflicts. The provided security systems conform to European standards and are essential for smoother running and higher safety of the detention centre. In addition to the technical support, the project provided full scale training program for the staff of both centres.

## **EU TWINNING PROJECT HOLDS ITS CLOSING EVENT**

On 18 February in Kiev the EU-funded Twinning project "Strengthening Activities of the National Accreditation Agency of Ukraine (NAAU)" presented its final results and held a press-conference.

The project with budget EUR 1,4 million and duration of 27 months was one the first Twinning projects launched by the European Commission in Ukraine to facilitate implementation of the ENP EU-Ukraine Action Plan. The aim of the project was to strengthen accreditation in Ukraine so that it would satisfy the requirements of the Action Plan concerning the Agreement on Conformity Assessment and Industrial Products Acceptance (ACAA).



The main purpose of the project was building up the knowledge among the

Ukrainian industry, vendors and national authorities about the importance of accreditation and conformity assessment requirements; to increase the competence and capacity of NAAU to assess the competence of laboratories, certification and inspection bodies, and by that fulfill European and international conformity assessments requirements.

## EU PROJECT TO STRENGTHEN STANDARDS OF STATISTICS PRODUCTION

On 18 February the EU-funded Statistics Twinning Light Project was officially launched at a press conference providing assistance to the State Statistics Committee of Ukraine (SSCU) to harmonise the official statistics of Ukraine to the standards of the European Union. The event was attended by Laura Garagnani, Head of the Operations Section of the EU Delegation to Ukraine and Ambassador Michael Borg-Hansen of Denmark. The partner for the project will be Statistics Denmark, the national statistics institute of Denmark.

The Twinning project will focus on SSCU's compliance with the European Statistics Code of Practice which sets standards for an independent, reliable statistics production and dissemination of high quality. The cooperation is aimed on

strengthening the methods of compilation for macro economic and structural business indicators.
