1. GENERAL INTRODUCTION

The European Diplomatic Programme (EDP) is now entering its 15th year. It was first established in November 1999 by the former Political Committee (doc 10509/00). To take account of developments since then, a revised set of principles governing the EDP (doc. 6488/09) was agreed in February 2009 by the Working Party on "CFSP Administrative Affairs and Protocol". Its current version was approved by COREPER on 7 November 2012 and adopted by the Council (ECOFIN) on 13 November 2012.

1.1 Aims

- To create personal networks among European diplomats.
- To raise common diplomatic awareness with regard to a specifically European dimension of diplomacy.
- To provide a learning environment where officials can be trained within an original framework which has no direct parallel within the national setting.

1.2 Target Group

The EDP is aimed at diplomats of all national Ministries of Foreign Affairs, as well as European External Action Service (EEAS), Commission and Council Secretariat officials. Priority is given to the training of junior diplomats and officials.

1.3. Training methods

The EDP cycle consists of four modules. During each module participants will attend a series of lectures and presentations, meetings or seminars. Their main purpose is two-fold: to increase individual knowledge of the subject matter and to prepare the participants to engage in group discussions which will lead to better understanding of individual positions of the EU member states as well as to the preparation by the EDP participants of group reports on the topics presented during the lectures and presentations,

The languages of instruction are French and/or English.

1.4 Certificate

A certificate is awarded to the participants upon completion of the course, on behalf of the EDP managers, by the closing Presidency (Module IV). No certificate will be awarded to participants who miss more than one module.

2. 15th EDITION OF THE EDP

The 15th Edition will take place under the Presidencies of Italy and Latvia. The programme will start in Rome on 22 – 24 October 2014 and will conclude in Riga (end of May/ beginning of June 2015).

2.1 Dates of the 15th Edition

Module I

22 – 24 October 2014, Rome, Italy

Module II

November 2014 - March 2015, exchange visits to Member States

Module III

13-17 April 2015 (tbc) Brussels, Belgium

Module IV

End of May/ Beginning of June 2015 (tbc) Riga, Latvia

2.2 Central theme for the 15th EDP

The central theme of the 15th edition of EDP will be "Emerging challenges and global

issues in current diplomacy". As mentioned in the conclusions of the European Council

on September 2010, "Europe is facing many challenges in a rapidly changing world". During

the four modules, participants will approach this subject from a theoretical and practical point

view focusing on content and skills.. Environment, climate change, security, energy,

migration, humanitarian aid, development, education and health will be among the issues to

be tentatively discussed. Among the skills to be tentatively covered during the programme are

the following: negotiation, political analysis and reporting, representation, strategic

communications or dealing with emergencies.

Participants will, by the end of the four modules, have a better and holistic understanding of

how the European Union is facing these emerging challenges and global issues as well as

individual Member States' s view on this specific issue.

2.3 Preliminary programme

Detailed programmes for the four modules will be circulated several weeks before each

module takes place.

Module I: 22 – 24 October 2014, Rome, Italy

An initial plenary session, in which also the Training Directors will participate, will give the

broad outline of the meeting activities. Participants will be divided into working groups on

various sub-themes and will be asked to produce a report summarising their discussions.

This event will coincide with the first informal Training Directors meeting.

Module II: November 2014 and March 2015

(Exchange programme between Member States of the European Union)

The exchange visits have multiple aims. Chief among these are to get to know the decision-

making process of another Member State, the European Commission, the General

Secretariat of the Council or the EEAS, their view with respect to the theme of the programme, and to network with counterparts.

Should the participant be unable to visit the assigned host institution, an alternative programme would be developed by the assigned host institution and the participants to fulfill the objectives of the European Diplomatic Programme.

Module III: 13- 17 April 2015 (tbc), Brussels, Belgium

This Module is divided into two sub modules.

During the first part (13-14 April), the EEAS, the General Secretariat of the Council and the Commission will organise a day and a half programme of presentations on topics related to the main theme, including question and answer sessions.

The second part (15-17 April) will consist of a simulated negotiation in which the young diplomats will represent the interests of a Member State or Institution. The negotiation training will be provided by experienced trainers who have conducted similar trainings during previous editions of the EDP.

Module IV: End of May / Beginning of June 2015(tbc), Riga, Latvia

(Final module and evaluation of the 15th Edition)

Module IV will consist of a panel discussions on the main theme of the programme followed by a question and answer sessions with the participants. The information gathered during the previous modules of the EDP will be the basis of this discussion. The participants will draft and present a Strategy Paper for the Council concerning measures to be taken in the context of the main theme of the programme - which model for effective EU participation and defence of its interests, priorities and values. After the presentations, certificates will be handed over. This event will coincide with the second informal Training Directors meeting.

3. APPLICATION PROCESS FOR THE 15TH EDITION

3.1 Procedure

EU Member States, the EEAS, the General Secretariat of the Council and the Commission may nominate 2 candidates and 1 reserve candidate. Should places be still available after this first round, a new selection process will be launched on September 1st.

All nominated candidates must be available to follow all four modules as listed above.
