Dear Petitioner,

Thank you for your petition dated 13 December 2011, concerning the rights of Lesbian, Gay, Bisexual and Transgender (LGBT) individuals in the Russian Federation. The High Representative and Vice President of the European Commission Catherine Ashton, who as you know received the petition in the margins of the European Parliament Plenary Session in Strasbourg, has asked us to reply.

The European Union is committed to the principle that all people should be able to enjoy the full range of human rights without discrimination. For this reason, the European Union has made its concerns clear to the Russian authorities over the introduction by the legal committee of the St. Petersburg Legislative Assembly of a bill prohibiting so-called 'propaganda of sodomy, lesbianism, bisexualism and transgenderism, and paedophilia to minors' and introducing administrative penalties and fines against such practices'.

Such a law is in contradiction with Russia's federal law and Russia's international obligations. Both the European Convention on Human Rights and the International Covenant on Civil and Political Rights stipulate, under Articles 10 and 19 respectively, that the freedom to receive and impart information cannot be limited, except under the ambit of public order. The EU is also concerned that such a law could reinforce prejudice and significantly worsen the human rights situation of LGBT individuals.

The EU has raised these concerns in recent contacts with the Russian authorities, including during the last round EU-Russia human rights consultations held on 29 November 2011 in Brussels. The EU has called on Russia to step up protection of LGBT individuals in Russia, notably in light of recent instances of threats and harassment.

The EU will continue to follow these developments closely.
