

**Heikki Talvitie** was appointed EU Special Representative for the **South Caucasus** on 7 July 2003 (Joint Action 2003/496/CFSP,OJ L 169, 8.7.2003, Joint Action 2003/872/CFSP, OJ L 326, 13.12.2003, Joint Action 2004/532/CFSP, OJ L 234, 3.7.2004, Joint Action 2005/100/CFSP, OJ L 31, 4.2.2005).
