

Pekka Haavisto was appointed EU Special Representative for **Sudan** on 18 July 2005. Running until 30 April 2007, his mandate is based on the EU's policy objectives in Sudan as regards efforts to achieve a political settlement of the conflict in Darfur, facilitate the implementation of the Comprehensive Peace Agreement and promote South-South dialogue, with due regard to the regional ramifications of these issues and to the principle of African ownership. He also contributes to ensuring maximum effectiveness of the EU's civilian-military action in support of the African Union mission in Sudan (AMIS).
