

CALL FOR OFFERS FOR THE ACQUISITION OF 28 SECURITY GUARD SENTRIES

The EU Delegation to Pakistan is interested in acquiring the following security equipment:

28 security guard houses



The security guard houses shall meet the following **technical and installation specifications**:

Technical mandatory specifications:

- One-seat cabin
- Square shape base. Aprox minimum measures (122 cmts. X 122 cmts.x 210 cmts)
- Pre-fabricated made of thermopile or equivalent waterproof plastic polymer
- 3 side windows aprox size 75x95 cms each. 1 window minimum shall be able to open with lock
- Door aprox. 60 cmts. wide
- Equipped with fan on roof
- 1 Electricity plug
- Inside light and switch light
- Lock on door (inside and outside lock)
- Long period of warranty

Technical desirable specifications

- Small fixed desk inside the house
- Double or triple window glass layers
- Lifetime warranty
- 1 additional (or more) electricity plugs
- Storage possibility inside the sentry (shelves, drawers or similar)

- Any other additional equipment of the guard house will be considered in favor of the offer

Installation Specifications

The supplier will be responsible for providing these 28 security guard houses at 23 different locations in Islamabad (Pakistan) and also for the proper transport and installation of all of them in 23 specific addresses in Islamabad.

- The guard house must be mounted on elevated steel or concrete platform depending on the location of each sentry.
- The platform must be 'box shape' [steel plates on 4 sides without gaps]
- The steel/concrete platform must be strong enough to support minimum: the weight of the cabin + 180kg
- For [x 22 pieces] the height of platform must be between: minimum 31inches & maximum 40inches
- For [x 2 pieces] the height of platform must be between: minimum 46inches & maximum 58inches
- The platform base must be wider than the base of the booth: minimum 14inches & maximum 17inches
- Steel mesh stairs must be /non-slip

The offers sent to the EU Delegation must clearly specify:

- Technical mandatory specifications
- Technical desirable specifications
- Installation specifications
- Photos of the exterior and interior of the houses.

And the split of cost as follows:

- Price per unit
- Cost of transport and installation per unit
- Period of warranty

Please note that the EU Delegation is VAT and taxes exempt so no taxes should be applied. Import duties or other costs if they were applicable should be clearly specified in the offer.
