## **EU SUPPORTS VENEZUELAN REFUGEES, MIGRANTS** AND HOST COMMUNITIES



4.5 million people have left Venezuela due to political instability, insecurity and economic collapse. This is the fastest growing refugee crisis in Latin American history and has become one of the biggest displacement crises in the world. The European Union stands with the people of Venezuela and is at the forefront of the international mobilisation to solve the crisis in the country and support a political, democratic, peaceful and Venezuelan-owned solution.

The EU provides Venezuelan refugees and migrants with emergency medical services, food assistance, shelter, legal information and support, protection initiatives, in particular NEEDS against gender-based violence, trafficking in human beings, as well as education in emergencies. The EU has been among the first ones to give support to the border area close to Cucuta's Simon Bolivar bridge and actively helps people in need along the main migratory routes, including host communities.



**€46 million** For example, the project "Cities of Solidarity" (€16 million) supports different local FOR DEVELOPMENT administrations in the region to facilitate acceptance of refugees and migrants within host communities and to improve their economic and social inclusion. Implemented together with UN-Habitat, UNHCR, and the IOM, the project is currently active in Colombia, Ecuador, Peru and the Dominican Republic and will be further extended to 10 additional cities in the region.



An EU contribution of €10 million to the Inter-American Development Bank's "Fiscal and Public Investment Expenditure Strengthening for Municipalities" programme makes it possible to leverage support totalling €147 million. It allows to scale up the programme's scope to focus on migrant-hosting communities and support local administrations in integrating migrants into the labour market and setting up a housing rental assistance fund.



Key areas of EU support are the identification and documentation of migrants and FOR STABILITY refugees, the reduction of tensions or risk of violence, countering trafficking in human **AND PEACE** beings, and fighting xenophobia and discrimination.



#### **TECHNICAL ASSISTANCE AND INFORMATION EXCHANGE**



The EU provides **technical assistance** to administrations in migration management, social protection and employment challenges in the region. In Peru EU technical assistance using Member States expertise supported the improvement of asylum services; in Brazil it supported the Public Defender's office to better protect migrant children; in Ecuador it helped the Ministry of Foreign Affairs face migration challenges.

#### EU WORKS FOR A POLITICAL SOLUTION TO THE CRISIS

Together with regional partners, the EU established the International Contact group in January 2019 with the objective to create the conditions for and provide support to a political process that can lead to the peaceful restoration of democracy.



#### **EU SUPPORTS THE QUITO PROCESS**



Governments in the region, under the Quito process, are working to harmonise regional policies and practices, scale up and coordinate their humanitarian response, improve access to host countries and communities, and address human rights and protection issues.



# DEVELOPMENT COOPERATION WITH LATIN AMERICAN AND CARIBBEAN COUNTRIES
