The entry into force of the EU-Singapore Free Trade Agreement (EUSFTA) on 21 November 2019 offers **significant business opportunities** for both EU and Singapore companies and traders. While ensuring effective customs controls, the EUSFTA aims at promoting trade facilitation and at providing preferential market access for goods originating in the EU and Singapore to each other's markets.
