Overview of Singapore's Electronics Industry

» Rich and diverse manufacturing hub

- Singapore has a strong manufacturing industry, with an average output of over 300 billion dollars on an annual basis.
- Of this, approximately 30%, or 90 billion dollars stems from the electronics industry.
- » Major player in global semiconductor supply chains
 - Singapore is a key node in the global supply chain of semiconductors, with many of the world's largest foundries, suppliers, equipment manufacturers carrying out operations in Singapore.
 - E.g., Infineon, Global Foundries, Siltronics, Applied Materials, etc.



Trade in Electronics under the EU-Singapore Free Trade Agreement ^{Webinar}

» The EU and Singapore are major trading partners

- Singapore exported approximately EUR 1.67 billion worth of electronic goods to the EU in 2020; and
- Singapore imported approximately EUR 2.96 billion worth of electronic goods from the EU in 2020.
- > These goods comprised:
 - Electronic data processing and office equipment;
 - Telecommunications equipment; and
 - Integrated circuits and electronic components.



Trade in Electronics between the EU and Singapore

Singapore as the Gateway into the ASEAN Region

» Trade in Electronics in ASEAN

- The electronics sector accounts for 20% to 50% of the total value of exports of most ASEAN countries.
- A large majority of the world's consumer electronics come from the ASEAN region, with many European MNCs such as Philips, Electrolux, Schneider etc. having operations in the region.
- » Availability of incentives to encourage development
 - There are wide range of incentives available to encourage the development of new technologies as well as to provide regional and international headquarter services from Singapore.
- » Singapore as the gateway to ASEAN
 - Singapore already acts primarily as the distribution centre for ASEAN exports of electronics goods, in particular for integrated circuits.
