## Decision of the Director-General for Budget and Administration of the European External Action Service

of 12/12/2019

### on the annual fixation of the amount of the grant paid to trainees the Delegations of the European Union and funded by the European External Action Service Exercise 2020

THE DIRECTOR-GENERAL FOR BUDGET AND ADMINISTRATION OF THE EUROPEAN  
EXTERNAL ACTION SERVICE,

Having regard to the Decision ADMIN(2017)28 of 21 December 2017 and ADMIN(2019) of 9 January 2019 of the Director-General for Budget and Administration of the EEAS on the rules related to traineeships in the delegations of the European Union et fixing the amount of the grants for 2019,

Having regard to Article 8, point 3, of the above-mentioned Decision which stipulates that the amount of the grant remains unchanged during the entire traineeship and that this amount is updated once per year taking into account the salaries of the local agents in a specific country,

considering the followings

- (1) The amount of the grant is based on the percentage of 25% of the monthly basic salary of a local agent in Functional Group I in the respective country and its maximum amount is limited to 25% of the basic remuneration for an official at grade AD 5/1.
- (2) It is necessary to take into consideration the evolution of the basic monthly remuneration of local agents fixed on 1 October 2019.

DECIDES:

A fixed monthly grant in EUR is paid according to the country of employment, as indicated in the annex, to the trainees who benefit from a financial support.

This decision takes effect on 1 January 2020
