The aim of this webinar is to strengthen the capacity of the staff of the Ministry of Justice of Uzbekistan in regulatory impact assessment and systematization of legislation. As the number of adopted legal acts has increased from 800 in 2016 to around 1450 in 2019, this workshop aims at reducing the significant burden on the public administration.

Effective enforcement of new regulations can lead to positive impact on the country's ambitious reform process towards transition to a democratic society governed by rule of law and market-economy principles. Improving the efficiency of legal services and of enforcement of judicial acts and acts of other state bodies are some of the key objectives of the National Development Action Strategy 2017-2021.
