

EU SUPPORT TO LIBYA



Through diplomatic action and concrete support, the European Union (EU) is assisting Libya's political transition towards a stable, functioning country and is supporting the United Nations (UN) led mediation efforts in this regard. The EU underlines the importance of inclusiveness of the political process and Libyan ownership, notably through the participation of all legitimate Libyan stakeholders.

The EU provides assistance to Libya through a specific set of measures tailored to the needs of the Libyan people. Support covers implementation of economic reforms including improved revenue transparency, improved governance and socio-economic conditions, respond to the humanitarian needs and empowerment of youth and civil society.

POLITICAL

The EU supports the UN-led mediation process and the efforts of Special Representative of the Secretary General Ghassan Salamé to implement the UN Action Plan on Libya and bring about a lasting solution to the political crisis. The EU works on building the country's institutions, strengthening civil society, the role of women and youth, and on fostering resilience through social dialogue, conflict prevention and mediation.

SECURITY

The EU is engaged in providing focussed support to Libya through its Common Security and Defence Policy (CSDP) missions and operations. The EU has significantly stepped up its presence at sea, to save lives and fight trafficking and smuggling networks.

EUNAVFOR Med Operation Sophia aims at countering human trafficking and smuggling by taking action against the criminal networks and disrupting their business model. Since its inception in June 2015 until last September, Operation Sophia **saved 44,916 lives in the Mediterranean, neutralised 551 boats and apprehended 151 facilitators.**

EUBAM plays an important role on border management, law enforcement and criminal justice, it has facilitated the training of the judicial police and the criminal investigation department and has organised study visits for the Libyan officials on border management.

In partnership with civil society and national authorities, the EU helps Libyans to create a safe and secure environment for the reconstruction of the country. EU support includes mine clearance, psychosocial support, armed violence reduction and mine risk education.

MIGRATION

Tangible results have been achieved on the ground thanks to the joint efforts under the trilateral **AU-EU-UN Taskforce** with more than **25,000 assisted voluntary retur**ns and more than **2,000 evacuations** of refugees by UNHCR.



SINCE JANUARY 2017, OVER 43,500 PEOPLE HAVE BEEN ASSISTED TO VOLUNTARILY RETURN FROM LIBYA AND NIGER TO THEIR HOMES, WHERE THEY RECEIVE REINTEGRATION SUPPORT WITH THE INTERNATIONAL ORGANISATION FOR MIGRATION (IOM)



MORE THAN 52,200 VULNERABLE MIGRANTS HAVE RECEIVED BLANKETS, CLOTHS AND HYGIENE KITS, OVER 26,000 PEOPLE HAD ACCESS TO MEDICAL ASSISTANCE AND 4 PRIMARY HEALTH CARE CENTRES RECEIVED MEDICAL EQUIPMENT
