The GSP Stakeholder Forum will officially launch the GSP Hub Project under the Generalised Scheme of Preferences (GSP). The Project aims at increasing the use of GSP, through bringing new EU investment, encouraging European companies to import from the beneficiary countries, and promoting international sustainability standards. The Forum will kick-off a series of thematic events and introduce new online tools which have been developed to centralise information on the GSP. It will also link GSP with sustainable development objectives, building in part on the recommendations of the GSP Mid-term Evaluation of 2018.

The Forum will focus on

- assessing the impact of COVID-19 on trade under GSP
- engaging business to benefit from the GSP
- involving civil society in monitoring by the European Commission of the GSP effects

EU's Generalised Scheme of Preferences removes or reduces tariffs for products imported into the EU market from vulnerable developing countries. This helps the beneficiary countries to stimulate economic growth and job creation, contributing to poverty alleviation while balancing respect for international values and standards, including core conventions on labour and human rights.

14:20 **ROUNDTABLE 1: HOW CAN GSP SUPPORT A POST-COVID RECOVERY?**

GSP beneficiaries are among the most vulnerable countries, which often means a high dependence on exports to the EU of mainly garment and footwear products (around 60%), but also agricultural products - notably in Africa. These sectors have been significantly disrupted due to falling consumption and the disruptions in supply/value chains which has led to significant loss of jobs and income, and hence has an impact on sustainable development commitments, health and migration in GSP beneficiary countries.

15:05 **ROUNDTABLE 2: THE RELEVANCE OF GSP FOR AFRICA, IS THERE A SCOPE FOR ITS BETTER USE?**

Africa is an important partner of the EU and enhancing the EU-Africa relations is a key political priority of the European Commission. The EU is Africa's main trading and investment partner as well as a cooperation assistance donor. Moreover, the African continent has the biggest number of the GSP beneficiaries - 38 countries in total, with the majority benefiting from the Everything But Arms (EBA) arrangement of GSP for least developed countries. The session will focus on sectors where diversification can be achieved and which can move up value-chains.

15:50 **ROUNDTABLE 3: GSP AND CENTRAL ASIA: HOW CAN EU TARIFF PREFERENCES PROMOTE SUSTAINABLE DEVELOPMENT?**

There are 3 countries in Central Asia that are benefiting from the EU's GSP: the Kyrgyz Republic (GSP+), Uzbekistan (GSP, applied for GSP+) and Tajikistan (GSP, interested in applying for GSP+). The scope of the EU's relations is linked to the readiness of individual Central Asian countries to undertake reforms and strengthen democracy and the rule of law, protect human rights, and ensure the independence of the judiciary. In economic terms it is important that the countries concerned embark on the market-oriented reforms leading to modernising and diversifying the economy, including by supporting the private sector. This session will present the state of play of implementation of the EU's Central Asia Strategy with GSP as integral part. It will highlight the benefits and remaining challenges under the GSP and will address the current status related to the fundamental human and labour rights conventions covered under the GSP regulation.
