The European Union, represented by the Delegation of the European Union to the Russian Federation (a diplomatic mission) intends to sign a framework service contract (FWC) for storage of its property and related services.

The provisional tender launch date is 18 March 2019. In order to be included in the list of potential candidates your message must be received on or before 17.00 hrs., 17 March 2019.

The application must contain the following information for being accepted in the list of potential candidates:

- Identification of the supplier indicating name, business address (full address of registration of the firm, if applicable), telephone and e-mail.

Contract subject of the tenders shall not exceed 142,000.00 € (or equivalent in other currency).

Inclusion on the list entails no obligation on the part of the Delegation concerning the award of the contract.

Contracts exceeding 142,000.00 \in will be subject of an ad-hoc publication. Vendors interested in participating to these tenders must reply to such publication. The inclusion in a vendors' list gives no automatic right to participate as candidate for these contracts above 142,000.00 \in .

Processing your reply involves the recording and processing of personal data (such as your name and address). Such data will be processed pursuant to Regulation (EC) No 45/2001 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data. Unless indicated otherwise, your replies to the questions and any personal data requested are required to evaluate your future tenders in accordance with the specifications of the invitations to tender and will be processed solely for that purpose by the Delegation.
